Thank you, we are NOT requesting Registry staff to provide legal advice in this matter at all; do not state, imply or infer such a misguided and erroneous message.

We have been given attached notification from Scott Treadwell Acting deputy Principal Registrar **instructing us that this Form CP12 must be directed via your Canberra ACT District Registry for filing**, this is CORRECT administrative notification.

This is NOT legal advice; it is appropriate administrative notification that the **ACT District Registry** is the lawful jurisdiction; and correct administrative notification that Scott Treadwell was duty bound to notify us of; and he did.

By the same court rules, Procedural Fairness demands that you are identically duty bound to fully clarify your 'half-stated' administrative advice: QUOTE: "indictable offences **cannot be dealt with** in the Court's **summary jurisdiction**" ENDQUOTE.

You were duty bound to advise that indictable offences cannot be dealt with in the Court's **summary jurisdiction**, and you half-discharged your obligation by administratively advising where it **CANNOT** be dealt with; you therefore are accordingly duty bound to advise **where it can be dealt with; as Scott Treadwell has.**

Please immediately advise (as Scott Treadwell did), if the Court's **summary jurisdiction** is not the appropriate jurisdiction; what jurisdiction of the **Canberra ACT District Registry** is the appropriate jurisdiction?

The South Australian Supreme Court Registry also frustrated access identically this way, by inappropriately classifying and administrative question as legal advice, this was made in my Janita Thurston case **that I won**

Court Registries are not employees or Officers of the Court, and are Statutory Authority employees, (public servants). Accordingly, I took the South Australian Supreme Court registry identical obfuscation to the Commonwealth Ombudsman. The registry was ordered by the Commonwealth Ombudsman to answer the administration question; and did so as it was duty bound.

In addition. you have court obligations as 'Stranger to The Court' as cited in High court of Australia THE QUEEN V. DAVISON 1954, <https://jade.io/article/65002>, cited by Dixon CJ, Viz. "The provisions of s. 12 and s. 18 of the Bankruptcy Act which vest jurisdiction in the court and in the officers of the court, show that neither the registrar nor the deputy registrar is an officer of the court but each is a stranger to the court. Instead of forming part of its official system and exercising the authority of an office in the Court, **the Registrar is now to be a stranger to the Court and its organization**".

Your Federal Court platform is failing filing at the moment, please accept my application seeking a hearing of prima facie indictable criminal felony acts alleged as conducted by C.H.O. Brett Sutton Victoria described in this application and seeking:

1. A writ for criminal indictment via committal hearing, of Victorian Chief Health Officer Brett Sutton to stand trial for **indictable offences of criminal False and Misleading Information and criminal deliberate Misrepresentation or Concealment and violations against the statute laws cited, and the people of the Commonwealth, listed hereunder:**
2. A writ of Mandamus, compelling Brett Sutton as the SOLE Victorian AUTHORITY decision maker, to perform mandatory duties correctly, of providing testable scientific evidence of the 'FACTUAL' Covid-19 existence, clinically shown by the RT-PCR 'test', where results definitively prove the Isolation and Purification and Characterisation of 'ANY' SARS-COV2 Virus which caused a Covid-19 infection in ANY human existing anywhere in Australia. Mr. Rizzo,

You are the first defendant in the High Court of Australia Solihin Millin criminal case citing you as defendant, currently proceeding as follows: <http://vaxrisk.org/CONSTITUTION.pdf>

As you note under, I am an aggrieved citizen by unlawful directions by Chief Health Officer Brett Sutton, and my accusations are herein now made that Sutton has, inter alia, committed criminal acts of the following, but not limited to:

- **False and Misleading Reports and Information**, [Criminal Code Act 1995 Division 137— False or misleading information 137.1, False or misleading information 424, 137.1A, Aggravated offence for giving false or misleading information 425, 137.2 False or misleading documents](#).
- **Interference with the exercise or performance of an Australian democratic or political right or duty; and the Constitution or a law of the Commonwealth. Penalty: Imprisonment for 3 years.** [Criminal Code Act 1995: 83.4 Interference with political rights and duties. \(1\) A person commits an offence if: \(a\) the person engages in conduct; and \(b\) the conduct involves the use of **force or violence, or intimidation, or the making of threats of any kind; and**](#)
[\(c\) the conduct results in interference with the exercise or performance, in Australia by any other person, of an Australian democratic or political right or duty; and](#)
[\(d\) the right or duty arises under the Constitution or a law of the Commonwealth. Penalty: Imprisonment for 3 years.](#); AND
- **Misfeasance In Public Office**, the tort of misfeasance in public office in an unauthorised and ultra vires exercise of government powers or functions.

Apart from the numerous criminal acts cited and others, among the unlawful and criminal actions and failures Sutton is guilty of, (as Sol Millin cites in his Notice of Constitutional Matter); **the focus of my request to you is as follows:**

- **Chief Health Officer Brett Sutton ‘falsely declared’ a PANDEMIC, BY False & Misleading Reports and Information, by repeated numerous criminal acts of commission and omission; a violation of [Criminal Code Act 1995 Division 137— False or misleading information 137.1, False or misleading information 424, 137.1A, Aggravated offence for giving false or misleading information 425, 137.2 False or misleading documents](#)**

NB: The Australian government DID NOT declare a PANDEMIC! It only declared a PANDEMIC ‘POTENTIAL’; only Brett Sutton FALSELY and REPEATEDLY declared a pandemic; and provided no science to prove this.

There is only ONE Federal overriding legal obligation upon Sutton in a national PANDEMIC emergency, and that is MANDATED by the [Australian Health Management Plan for Pandemic Influenza](#).

THIS LEGAL OBLIGATION, DEMANDS Sutton devise science-based medical responses where he is obliged to do scientific-epidemiological-pandemic studies to PROVE A PANDEMIC & CATASTROPHIC DEATH-RISK EXISTS OR IS IN CONTROL OR OUT OF CONTROL; he did none!

HIS BREACH OF LAWFUL OBLIGATIONS ARE AS FOLLOWS:

The Chief Health Officer is lawfully bound to implement:

- **the use of existing systems and governance mechanisms**, particularly those for seasonal influenza.
- **evidence-based decision making**.
- **monitor the emergence of diseases with pandemic potential** and investigating outbreaks if they occur.
- **identify and characterise the nature of the disease**.
- **ensure a proportionate response**.

ALL OF THESE LAWFUL OBLIGATIONS ARE VIOLATED by Sutton; and no such scientific-epidemiological studies to PROVE a pandemic & catastrophic death-risk exists, have been conducted by Sutton as lawfully required.
